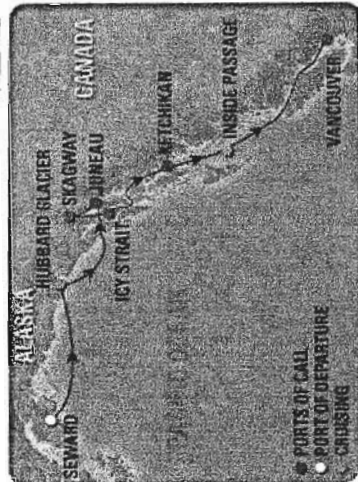

PAYMENT POLICY

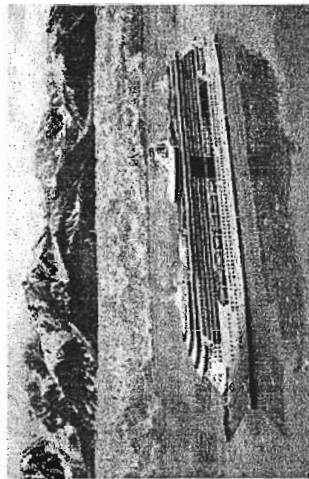

**USS Salamonie Alaskan Group 10-Day Reunion Cruisetour
3 Day Land/7 Day Cruise (June 10 - June 20, 2008)**

The attached (enclosed) brochure contains the itinerary, detailed information regarding the scheduled cruise, Reservation Form and "Things to Know Before You Go". There are several items we would like to highlight:

CRITICAL

- We were able to reserve only 40 cabins: 10 Balcony, 20 Ocean View, and 10 Inside (Prices are in the brochure). It appears there is a lot of interest in this trip. If our response exceeds the amount reserved, we may be able to obtain additional cabins. **However, it is possible additional cabins will NOT be at our group rate.** Since the Alaskan cruises are so popular, it is not uncommon for them to be sold out in June or July. TIME IS OF THE ESSENCE.
- The total cost of this trip will include the 10-day cruisetour amount, airfare, travel insurance, and possible transfer fees, plus some meals during the 3-day land portion. The brochure outlines what is included and what is excluded.

MENNO TRAVEL:

- Founded in 1953. Maureen Russell is an experienced, efficient travel consultant. We recommend you utilize her services for your air travel plans to coordinate with this cruise, including an early and/or delayed departure.
- Upon receipt of the Reservation Form, Menno will forward a letter indicating the cabin number you have been assigned and a web site available to review additional excursions that may be available to you from the cruise line. You will be able to reserve and pay for these excursions ahead of time if you desire. Information is included regarding activity level (low, moderate, strenuous walking, climbing, etc.), to help you make a decision.
- You will also receive information regarding travel insurance (which is highly recommended). The travel insurance is purchased directly from the insurance company. You will want to make sure you insure both the cruise and your airline fare, which you can add to the policy when your airline tickets are purchased.
- You will receive an Alaskan booklet which describes ports of call, suggested clothing, etc.
- Airline tickets --- rates for 2008 are normally published around July/August. Menno has a software program called "MARVIN", which constantly searches for better connections/better fares. If there is a savings in excess of \$100, your airline reservation will be changed to provide the better connection and/or fare.
- Two to three weeks before cruise time, Menno will forward all necessary tickets, documents, name badges, or other information that has become available to help.
- Finally, Maureen is happy to answer your questions and provide any assistance required to make this trip a memorable and happy experience.

INSURANCE:

- Two different policies are available. Brochures will be provided to you with the reservation acknowledgment package. For planning purposes if you are between 60 and 70 years old and your travel cost is \$2,500, your premium on the "Classic" policy will be \$149 (\$298 for two), or \$220 (\$440 for two) for the "Deluxe" policy. The basic difference between the two policies relates to the emergency medical/dental/transportation coverage. The brochures outline the coverage very clearly (user friendly).

ADDITIONAL INFORMATION:

- Transportation during the land portion will be via motor coach rather than rail. We are advised the activity level is low to moderate. You are welcome to return to the motor coach whenever you like.

Cruise Documents

Proof of Citizenship

A valid U.S. passport is required for each passenger traveling. Your passport must be valid for at least 6 months after your last date of travel. A passenger's name as listed on their reservation form should match their passport. Reissue of documents due to incorrect names listed on your reservation form will result in a fee paid by the traveler.

Passport applications and pictures are available at Menno Travel Service. If you are not a U. S. citizen, you must check with your embassy and the U.S. Citizenship and Immigration Services for re-entry and any visa requirements.

Optional Insurance

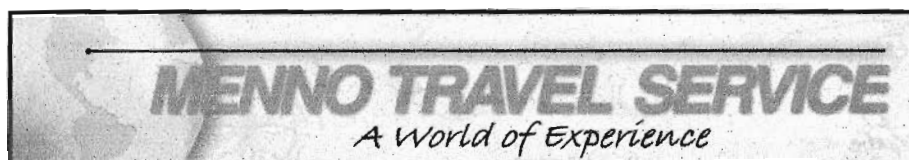
